# **Highlights**



- The Columbia County Department of Health welcomed Christina McKenna and Demba Keita from the New York State Public Health Corps Fellowship Program!
- Distributed a Community Health Needs Assessment and gathered feedback from **867** unduplicated individuals to evaluate the community's health status, needs and issues.
- Collected **1,906** pounds of home-generated sharps through the community sharps collection program to aid in safe disposal.
- Enhanced our social media presence, reaching **203** followers on X and **6,967** followers on Facebook with an average reach of **7,835**. Our smartphone application has also been downloaded **3,297** times.
- Hosted **87** educational events and attended **35** community outreach events, reaching an estimated **3,500** individuals.
- Conducted **5,407** communicable disease investigations and continued disease outbreak surveillance of all nursing homes and assisted living facilities within Columbia County.
- The Migrant Health Program visited **eight** farms in 2024 and were able to provide education and screenings for blood pressure and blood sugar to **197** seasonal farm workers.
- Our Community Health Worker (CHW), Spanish Speaking, had **984** migrant encounters for which she provided translation services, transportation for medical services, and assisted with access to social services. Our CHW also assisted **seven** pregnant migrant women to their appointments in 2024.
- Hosted **37** sexually transmitted disease (STD) clinics and served **75** patients with appropriate testing, medication and referrals.
- New York State launched the El-Hub, a new web-based software, in October, 2024, which was adopted by our Early Intervention & Preschool Services staff to assist with reporting child information from referral (intake) to transition, managing provider data, claims creation, billing and payments.



## **Public Health Education**

The mission of the Health Education division of the Columbia County Department of Health is to improve the Public's Health through education, evidence-based interventions, and effective communication. The Public Health Promotion program educates the community about how to prevent disease in order to improve health and quality of life.



The program works with organizations to develop healthy policies and environments, provides community health workshops on healthy living and disease prevention, and teams up with community partners to study the health of the community (Community Health Assessment) and conduct activities to improve community health (Community Health Improvement Plan).

## **Tickborne Disease**

In 2024, the Health Education Division was awarded grant funding to increase their climate and health adaptation efforts. Since Columbia County has consistently outnumbered other NYS counties (excluding NYC) in rates of tickborne disease, the division focused their efforts on tick prevention and management. With this funding, they were able to create educational materials and 997 tick kits for distribution throughout the community. They also released a survey to assess community knowledge of tick-related information and to determine areas where efforts should be focused. 201 Community members responded to the survey. The division attended 12 events and partnered with local farms, libraries, conservation areas, parks and historic sites to deliver resources and education to the community at sites where they work and play outdoors!







# Adolescent Tobacco Use Prevention Act (ATUPA)

The Columbia County Department of Health is tasked with enforcing Article 13–F: Regulation of Tobacco products, Herbal Cigarettes and Smoking paraphernalia; Distribution to minors of the Public Health Law in the State of New York. Under this law, program tasks include underage compliance checks at all retailers licensed to sell tobacco products, field visits to ensure compliance with Article 13–F regulations and enforcement of these laws through our legal hearing process. In 2024, there were 66 active facilities that sell tobacco products in Columbia County. In 2019, New York State passed legislation to change the legal buying age for tobacco products from 18 to 21 years of age. With the passing of this law, CCDOH started completing compliance checks with underage inspectors between the ages of 18–20. In 2024, there were five compliance checks completed by adults and 71 by minors. Two registered tobacco retailers illegally sold products to underage inspectors employed by this office, enforcement was upheld by a legal hearing and fines were collected.

In 2020, New York State made the sale of flavored vapor products illegal under Article 13-F regardless of age. This office has been tasked with enforcing this ban and it has been an uphill battle for four years. Tobacco retailers make large sums of money from selling flavored vapes and are now concealing them in locked cabinet and hidden boxes. CCDOH has no authority to seize illegal products at this time, however all enforcements and fines for these items being offered for sale in facilities have been upheld through legal hearings. There were **731** illegal flavored vapes found with fines totaling \$17,647.00 for all Article 13-F violations in 2024.









## **Emergency Preparedness**

The Public Health Emergency Preparedness (PHEP)
Program strives to build the capacity of the health
department to prepare for, respond to, and
recover from various emergencies. The PHEP
program also serves as a resource to emergency
services agencies for subject matter expertise as it
relates to public health.



The PHEP Program also coordinates with the office of emergency management to support trainings, exercises, and events to support the preparedness efforts of other county departments and the community.

# Medical Reserve Corps (MRC)

The Medical Reserve Corps (MRC) is a national network of volunteers who help make their communities stronger and healthier during disasters and every day.

The Columbia County MRC is organized and sponsored by the Columbia County Department of Health. MRC volunteers include medical and public health professionals as well as community members without any healthcare background or experience.

#### MRC activities include:

- Point of Dispensing (POD) operations
- Emergency Shelter operations
- Training opportunities including CPR, Stop the Bleed, and more!
- Specialised teams (Mental Health, Animal response, etc)

## **Immunization**


Vaccines are the foundation of Public Health, and have been used to prevent more than **30** life threatening diseases and illnesses. They have saved more lives than any other medical intervention. Immunization services are provided to infants, children and adults for school, work, and travel. Over the past decade, Immunization has seen many changes and advancements. Columbia County has been busy keeping up with these changes to offer up to date care for the residents of the county. Some examples include the over **25,000** COVID vaccines administered since the pandemic started in 2019. Over **875** Rabies vaccines have been provided to residents to prevent the life threatening rabies virus since 2015. CCDOH continues to work with local fruit farms to provide medical care and immunizations to migrant seasonal workers. We have provided over **1,950** vaccines since 2015 to help minimize disease in this community.

In recent years, there has been an increase in the population in the county, which has put more of a demand on staff requiring an increase in services, such as vaccine administration, records translation and referral to other medical resources. We continue to work with our community partners, including local pharmacies, to provide vaccine services to the public. Relationships have strengthened between this agency and others, like doctor's offices, school districts, and children's camps through site visits and educational opportunities in order to provide the best level of care. The Immunization program works closely with NYSDOH to ensure that local healthcare providers are in compliance with State regulations.

## Healthy Neighborhoods Program

The Healthy Neighborhoods Program (HNP) is a **FREE** service that is funded by the New York State Department of Health which aims to improve the health, safety, and environmental living conditions for **all residents in Columbia County**. HNP specialists work with residents to reduce asthma triggers and indoor air pollution, and increase fire safety and radon testing in their homes. There are no income or age requirements to be eligible for the program; however, a **home visit is required**. During the home visit, HNP specialists may identify safety or health hazards and provide information and free materials to help improve the area of concern. All renters and homeowners in Columbia County are encouraged to participate!
